I wish to advise that I have decided to put my name forward as a candidate for the Kapiti Coast District Council in the Paraparaumu Ward for the October elections.

My reason for doing this I believe that I can make a positive contribution to the community with the experience I have had in the commercial sector over the past 25 years.

My background is as follows. Seven years as Chief Executive Officer of Wilsons Cement in Auckland (a large private company owned by two corporates) 5 years as a director and latterly Managing Director of The Golden Bay Cement Group (a medium Wellington based public company.)
