## **Welcome from Mayor Guppy, Upper Hutt City Council**

Mayor Guppy welcomed members and said that Upper Hutt City would shortly be opening a new Art and Education Centre and members would be able to tour the building later in the day if they so wished. Mayor Guppy said that Upper Hutt were team players and wished to see a better transport network for the whole region. The integration of the Wairarapa Corridor Plan was very important as were improvements to State Highway 2 given that 50% of the citizens of Upper Hutt travelled south each morning and returned in the evening. Mayor Guppy listed a number of projects which were supported by the Upper Hutt City Council and said there was also strong support for the extension of commuter services beyond Upper Hutt Central to Timberlea and Cruickshank Road.

Mayor Guppy trusted members will enjoy their visit to the Upper Hutt City Council and wished everyone a successful meeting.

#### **RLT 96 Public Participation**

##### **Rosemary Young and Dene Wade, Pukerua Bay Residents Association**

Ms Young and Mr Wade said that pedestrian separation was needed at Pukerua Bay and demonstrated the danger to pedestrians as they attempted to cross State Highway 1 at the Taihana Road West crossing point. A video showed how pedestrians were risking their lives by waiting in the middle of the Highway; their movements were also shown to clash with turning traffic at a major intersection; traffic was shown passing pedestrians at high speeds; it was also noted how the Taihana Road West intersection was the main crossing point to reach public transport.

The Residents Association believed that until a pedestrian overbridge is economically viable improvements to pedestrian safety at the intersection can best be achieved by better signage and reducing the speeds of through traffic on the State Highway.

**Jane Dawson, Cycle Aware Wellington**

Jane Dawson urged members to support the Draft Regional Cycling Strategy for consideration at today's meeting.

Cycle Aware Wellington also supported the aim of creating a cycling culture among agencies in the region including Transit New Zealand and local authorities and also strongly supported the proposal for a Regional Co-ordinator.

*“Mr Hasell commented that the submission was not correct in its summary of the process being followed. It was Transit's objective that the new construction cost estimate (a new estimate rather than an update of previous estimates) would allow a decision to be reached, in principle, on the funding and likely timing of the project, without the need for any additional field investigation.*

*However Transit had agreed that should it prove necessary, once the cost was known, for further work to be commissioned it would then seek funding accordingly.”*
