**Regional Policy Statement Review (RPS)**

Mr Southey expressed his disappointment at the short notice given to councillors and appointed members of the Committee to attend the Regional Policy Statement workshop on 8 November. Officers agreed to relay the notice concern back to the relevant staff.

Mr Read attended the workshop and provided an update for the members.

**New Structure**

Mr Dalziell reported that there was an element of confusion regarding the new management structure making it difficult for ratepayers to know which divisional manager to contact.

Officers reported that information and key contacts for the Catchment Management Division would feature in a forthcoming Rural Services newsletter. It was noted that the Environment Management Division structure had featured in the previous Rural Services newsletter.

### **Biosecurity – 1080 Reassessment**

Members noted that the submission period had been extended to the end of January.

### **Flood Protection – Restrictions on Waihenga Bridge**

Officers updated the Committee on Transit NZ's proposal to close the Waihenga Bridge when the gauge reading reached 4.5m at Waihenga due to safety concerns from scouring around the bridge piles. It was noted that Transit NZ had not written or consulted with GW regarding their proposal.

Officers were asked to write to Transit NZ seeking additional information.

### **Land Management – Farm Environment Awards**

Members were advised that it had been decided to proceed with the Awards for this year given the number of entries that had now been received. It was noted that a review of the Awards was considered appropriate.

### **BioWorks – Land Management Planting**

Mr Dalziell noted from the BioWorks report that they were doing much of Land Management's riparian and shelterbelt planting programmes and queried whether this would impact on their core possum control contract work.

Members were advised that the Upper Hutt staff undertaking this work were employed to undertake additional revenue work and not the Animal Health Board operational programmes.
