WRS 16      **Section 16 Mediation Update (oral report)**

Jane Davis confirmed that both Upper Hutt City Council and Hutt City Council have both referred Greater Wellington's proposal to mediation and outlined the process to be followed. She reported that a mediator (Geoff Sharp) has been appointed and that a mediation meeting is to be held this coming Friday (20<sup>th</sup> April) with Tuesday 24<sup>th</sup> set aside as a reserve day if required.

WRS 17      **Regional EDA Update (oral report)**

Murray McCaw reported that the transition board is meeting weekly. Meetings have been held with Enterprise Kapiti and Go Wairarapa to discuss transition arrangements to be finalised by June 2007. The board has met with the Positively Wellington board to discuss changeover, and purchase of fixed assets. Work is proceeding to procure funding from MTU money for business incubators and centres of excellence.

*Regional EDA Board Appointment Process (Update)* Jane Davis

Jane Davis updated the Committee on the process to appoint the EDA Board. She reminded the Committee that at its meeting on the 6<sup>th</sup> March it considered a process to identify the 7 people for appointment to the newly established regional economic development agency (Regional EDA Ltd). The Committee agreed to a process led by the Chairman of the WRS Committee and supported by the Chief Executives Group. She reminded that Committee that it is to make the final recommendations to Greater Wellington for the appointments. She then confirmed the process as set out below:

Step 1    A search of relevant databases to be undertaken by officers (Greater Wellington)

Step 2    Chief Executives to identify names, in consultation with

## Mayors/Chairman of Regional Council

- Step 3 Lists from Steps 1 and 2 combined into master list and supplied to all Chief Executives
- Step 4 Chief Executives to reduce the list to 10-15 names at CEG meeting on 13th April
- Step 5 Shortlist to be given to Sir John for consideration
- Step 6 7 names to be presented to WRS Committee by Sir John for consideration at its meeting on the 9th May
- Step 7 GW makes appointments on the recommendation of the WRS Committee (special meeting will be required in May)

Finally, she told the Committee that the Chief Executives have now completed the process up to Step 5.
